Private Education loan

Southampton Solent University does not endorse any private education loan provider located in the United States who offer loans for study at foreign schools. At the date of publication of this document only one private education provider issues loans to foreign schools, Sallie Mae.

	<p>Southampton Solent will certify loans from Sallie Mae, but only when a certification request is received from Sallie Mae, and only when a student has submitted a Cost of Attendance calculation to the University which is considered to be an accurate record of the student's cost of attendance.</p>

At the date of publication of this document only one private education provider issues loans to foreign schools, Sallie Mae; therefore any reference to Sallie Mae on Southampton Solent communications does not represent the existence of a preferred lender; merely that it is a lender.
